
It's Pool Party time again!!! Bring the kids and come on out for a good time.

Above: Dinnertime


Left: Frolicking in the water

- ▶ What's not included-gratuities, beverages (both soda and alcohol), items of personal nature, ship photography, shore excursions and travel insurance. (Gratuities are paid at the end of the sailing to waiter-\$3.50 per person per day, assistant waiter-\$2.00 per person per day, and cabin steward-\$3.50 per person per day.
- ▶ Shore excursions are available to book online or they can be mailed in when you receive your cruise documents. They can also be booked on board.
- ▶ If you have an AARP card or the Carnival discount coupons from the entertainment books, you may be entitled to a further reduction on the cost of the cruise. Let Jan know when you book the cruise.
- ▶ Payments for the cruise are payable to AAA. Jan Hylen will be working with our group to book each individual. Her number is 934-5170. Call her to make reservations or to pay by credit card. Mention that you are with the Omaha Ski Club group.
