Join members of the Omaha Ski Club in Sun Valley Idaho for a week of skiing. Price includes round trip airfare to Sun Valley, baggage handling and airport transfers, lodging and 5 days of lift tickets. We will be staying in the Sun Valley Lodge Apartments, adjacent to the Sun Valley Lodge. These accommodations are just a shuttle ride from the lifts. The complimentary shuttle service runs every 20 minutes. The lodge apartments are close to the Sun Valley Village. This is the original Village from the beginning of Sun Valley with lots of nostalgia, shopping, restaurants, bars and nightclubs. The Jacuzzi is the size of a swimming pool plus there is an exercise room and health club within walking distance of the lodging where there are change rooms and showers.

**Sun Valley Ski Area** consists of two mountains. Bald Mountain has 3400 vertical feet on 2054 acres of terrain. A total of 13 chair lifts and 65 varied runs offer something for skiers of all ages and skill levels. Dollar Mountain is the perfect place to get acquainted with the thrill of downhill. The mountain features the Wundercarpet that effortlessly whisks children of all ages to the top of the run.

We have excellent **flights** leaving Omaha at 8:40 AM going to Sun Valley. The return trip departure leaves Sun Valley at 9:31 or 11:20 AM and returns to Omaha at 4 PM on Sunday March 5<sup>th</sup>. Just enough time to unpack and relax before starting your busy workweek.

**Lift tickets** (5 of 6 day) are included in the price of the trip. If you wish to purchase a 6 of 7 day lift ticket, you must do so with the final payment. The additional cost of this is \$40.00.

**Travel insurance** is available for the cost of \$52.00 for up to \$1200.00 worth of insurance. Insurance must be purchased prior to 1/10/2005. Insurance covers the following:

- \$10,000 emergency medical expense/assistance incurred during your trip to treat any condition that is acute or life threatening.

- \$500 trip delay
- \$1000 for baggage/travel documents

- 24-hour hotline available 365 days a year who will refer you to the appropriate and legal providers if needed.

## OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$10.00 charge on any returned check.

## TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7) below. Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7) below.
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

## CANCELLATIONS AND REFUNDS

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will

result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.

- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 9) above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

## BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption

# Presidents' Corner

The ski season is finally here. Most of the ski resorts out west are open (or will be shortly). The snow started early and has continued every couple of days. What does this mean for us? A great ski season is just ahead for all of us.

There is still limited space available on three of our trips: New Years, Steamboat, and Sun Valley. Due to the low number of people who signed up for the Vail trip in January, we have had to cancel it. The slow economy, really cold weather in January, and the low number of current members, were all factors in having to cancel the trip.

Membership in the club has declined in the past few years. There are a number of reasons why the membership is going down. According to the National Ski Council Federation, clubs across the whole country are experiencing the same problem. In a recent e-mail from the Council, they gave these reasons for the decline:

- In 2000, participation in sports and fitness activities among people ages 16 and over took a real dip and has not yet recovered. Instead of sports, people are watching television and taking part in computer activities. Among leisure activities, gaming is the fastest growing.
- The ski industry is not helping the sport grow. The number of skiers and snowboarders are declining. Skier days are up but this is not due to more skiers, but to the same skiers skiing more days due to the low cost of season passes.
- Two age groups of skiers are growing, 19 to 20 years of and 40 plus group. The 30 to 40 year old group is too time starved to go skiing. The generation X (20-29) males, are fitness freaks. They are joining for-profit adventure clubs instead of ski clubs.
- Statistics show that 40% of club skiers skip one or more seasons every five years. Skiers are looking more to have a good time on their trips rather than become advanced or expert skiers.
- And lastly, the ski industry has no voice for the consumers. They need help from clubs and ski councils.

In a more local story, Bahnsen's is closing its doors. They have sold and rented skis in our area for the past 45 years. The poor economy and competition from the big chain stores have hurt them in the past few years. We will miss their personal attention and the quality tuning service they have provided all of us over the years.

Merry Christmas and a Happy New year from myself and the rest of the Omaha Ski club board.
