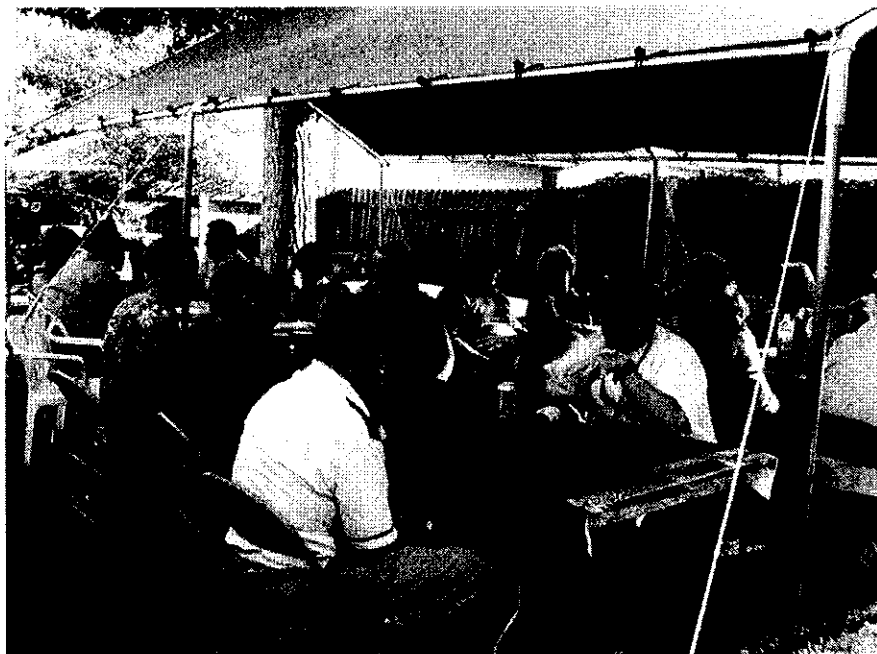

# NIOBRARA TRIP ---- August 12-14, 2005

We are once again heading northwest for a weekend outing and a day of tubing on the scenic Niobrara River. But this year we've added a couple of twists for a change of pace and a little variety. Please look at the information below and contact me in the next few days to let me know if you want me to reserve you a spot. Lodging is on first come first serve basis and is limited, so please let me know what type of lodging you want and I will do my best to arrange it for you.

## An Overview:

Friday and Saturday nights we will be staying just outside of Long Pine, NE, at a place called The Pines, about 250 miles from Omaha. I've reserved their entire area, eight cabins and one house. These are all rustic accommodations, but come with air conditioning, bathroom (with shower) and a kitchenette with fridge and stove. Fire pits and tables for wine tasting, smores or board games at night are right outside of most cabins. For Friday and Saturday evenings, small tube rentals and available at The Pines and they can drop you off up the creek about a mile, with the winding creek ending up right at our cabins. My three boys did this last year and said it was great, but a little cold (however, we did it near sunset). Here is a picture: <http://www.cityoflongpine.org/fishingrecreation.html>

Saturday we will drive about 40 miles up to the Niobrara area and park cars at our end of tube float area. A bus will transport us up river to our drop off point. Covered tubes (most preferred by our group), canoes or kayaks are available for rent. The tube float takes about 4-5 hours and we stop at Smith Falls for lunch or a dip in the chilling falls. Backpacker magazine rated this one of the top ten river areas in the nation a while back.

## OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$10.00 charge on any returned check.

## TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7) below. Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7) below.
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

## CANCELLATIONS AND REFUNDS

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will

result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.

- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 9) above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

## BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption

Saturday night, after we get back and freshen up we can all rendezvous at the Hidden Paradise restaurant near Long Pine (this is optional) for a great meal at what used to be the prime resort area for this area in its hey day (which is now basically summer cabins up and down a creek). Good food, reasonable price and later in the evening there is usually a band playing.

Sunday our plans are to try to get everyone to meet up for breakfast down the road in Basset at the old Range Cafe, which looks like a place right out of the 1950's and has been beautifully kept up all these years. A breakfast buffet will be available. (Note: The Range Cafe is currently having its kitchen rebuilt. If it is not ready by trip time we will eat at Jenny's Cafe in Long Pine instead).

### Okay, here are the specifics.

#### What is available:

Four cabins with one double bed. \$49 per person for the two nights based on double occupancy (perfect for couples)

Four cabins with two double beds. \$54 per person for the two nights, based on double occupancy (great for families or great for two singles)

The House - Sleeps 8 \$39 per person for the two nights, based on at least four people. Rates may drop if more than four people.

The House is just 2-3 minutes walk from the cabins. The cabins are all clustered together.

NOTE: Special lodging discount for children. Only \$9 if minimum adult occupancy has been met.

Camping at a local state park may be available, but you are on your own for that. A \$9 trip fee will be applied if you do not stay at our group lodging.

#### Niobrara tube float info:

Tube rental \$26 per person (I currently have 16 reserved)

Cooler tubes \$10

Canoe rental \$48 per canoe (if available)

Kayak \$33 (if available)

Bus fare \$8

\*Extra Riders ( Canoe/Tube) Under 8 .....Free w/ paying adult, 8 and over.....\$ 15 each

**Food:** No meals or food is included in cost of trip.

**Transportation:** Responsibility of each member. No transportation is provided, except bus to river access (see above fee).

**Deposits:** All fees and forms are due by July 10th. However, please contact me now to assure we have a room for you. A trip application (<http://www.omahaskiclub.org/TripApp0304.pdf>) and current membership <http://www.omahaskiclub.org/memb%20app%2005-06.pdf> is required.
