In Remembrance . . .

We regret having to announce the passing of long time Omaha Ski Club life member Dave Lawler. Dave was an OSC member for over 30 years, with most of those years spent in service to our Club. In the days before we all had email, Dave would spend time every month laying out the hardcopy first draft of our newsletter, including processing photos, proofing text, making copies, manually addressing and labeling all copies, and finally driving the zip-code sorted bundled newsletters to the downtown post office. As a member of the Bar association in Iowa, he would provide an endless number of hours helping to keep the Club in proper legal standing and preserve our non-profit status. Dave was awarded an Omaha Ski Club life membership in honor of his unselfish contributions to our Club. Dave was also a long time ski patroller and instructor at the Mount Crescent Ski Area. Dave will be greatly missed by our club.

Here is Dave's complete obituary:

David J. Lawler Jr., 64, of Council Bluffs, formerly of Clare and Fort Dodge, Iowa, passed away April 10, 2015, at his home.

David Joseph Lawler Jr., was born September 15, 1950, in Fort Dodge. He attended St. Matthews School in Clare and graduated from St. Edmond High School in 1968. David graduated from Benedictine College in Atchison, Kan., attended the University of Iowa - College of Law, received his law degree and was admitted to the Iowa Bar. After serving as a clerk for former Supreme Court Justice David Harris, David moved back to Fort Dodge and opened his own practice.

David eventually moved to Council Bluffs and worked for the Legal Services of Iowa before returning to private practice. He was a ski instructor and worked as ski patrol at Mount Crescent. David collected model railroad trains and participated in RAGBRAI for many years.

He was preceded in death by his parents, David J. Sr. and Irene (Meyers) Lawler.

David is survived by his siblings, Ellen (Jack) Cottrell, of Fort Dodge, Rev. Bruce Lawler, of Larchwood, Iowa and Marcia (Pete) Cooper, of Lee's Summit, Mo.; and 5 nieces and nephews, Carl Cottrell and Marianne Stepanian, of Watertown, Mass., Carrie and Matt Becker, of Las Vegas, Nev., Will and Lea Petrie, of Kansas City, Mo., Teresa and Jason Satchell, of Overland Park, Kan., Katherine Petrie, of Lee's Summit, Mo.

A Mass of Christian Burial will be 10:30 a.m., Monday, April 20, 2015, at St. Matthew's Church, Clare. A visitation will be one hour prior at the church. Burial will follow at St. James Cemetery, Clare. Memorials may be left to the St. Edmond Catholic School System.

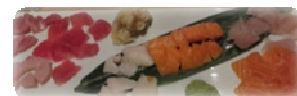

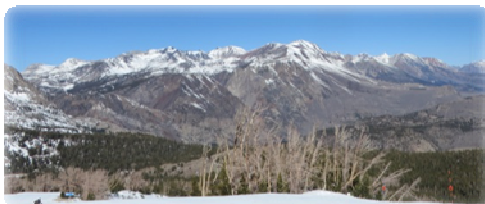

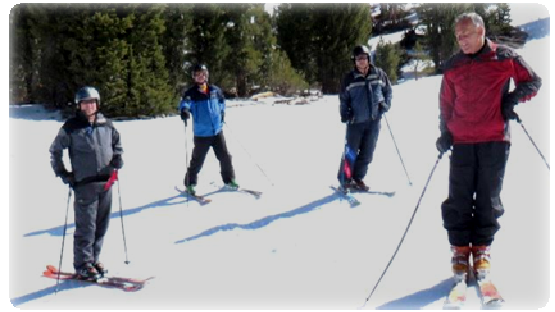

in town, and the Stockyard restaurant in the Village. The restaurants were abundant, the food was good and the service was above average. Pricing wasn't too bad either.

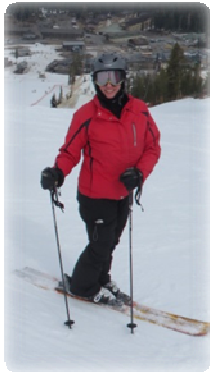
