



Chicago Metropolitan Ski Council (CMSC) Spring Fling April 9-14, 2016 Snowbird, Utah



We checked in at the Cliff Lodge in Snowbird for CMSC Spring Fling trip on Saturday morning. I skied at Alta for the day. When I returned, I checked to see

whether Ben and Dale had arrived. They hadn't arrived yet so Steve and I went down to the center base area and looked around. We found the Tram Club and had a beer and then walked back through the slushy snow to the Cliff Lodge. By the time we got back, Ben and Dale had arrived. We all went to the El Chanate restaurant and Tequila bar for dinner. We called it a night after that. Mark arrived from Colorado Springs early the next morning.



Sunday morning we had a brief meeting with Scott Appleman from AppleCore Sports. We then attended the CMSC welcome party at the Aerie restaurant on the top floor of the Cliff Lodge where we had a great buffet breakfast. After breakfast, Scott gave us a tour of the mountain. We started at the Peruvian lift and went through the tunnel to get to Mineral Basin on the other side. The tunnel was about 600 feet long with a magic carpet transporting people to the other side. Along the way, articles showed a history of the early mining days of the region. At the halfway point, the tunnel was about 200 feet underground. Our tour ended at the base of the tram. After skiing all day, I



stopped at the Tram Club for a shot and a \$1 beer. When finished, I took the Chickadee lift back to The Cliff Lodge to avoid the slush. We went to the Wildflower Restaurant for dinner that evening.



Monday we started the day with breakfast buffet at the Atrium restaurant. We then explored Snowbird, staying on groomed runs until the snow softened up. The snow was hard in the mornings and became slushy by the end of the day. It was typical spring skiing conditions. Some of us went to El Chanate restaurant and Tequila bar for dinner and others returned to the Wildflower. There were not many choices for dinner in the area.



Tuesday most of us upgraded our lift tickets to go ski at Alta. We took the Peruvian lift, went through the tunnel and skied down to the Baldy lift. This lift took us up to the gate between Alta and Snowbird where skiers only can access Alta. The Superior lift was closed so we couldn't ski in that area. I'm glad I had a chance to ski it on Saturday. That evening we went to the Tram Club for wings.





Our last day on Wednesday, we skied at Snowbird again and found trails on the front side of the mountain, such as Chips, that we hadn't skied yet. The weather deteriorated rapidly that afternoon, with wet snow and fog near the top of the area and rain near the base. Most of us ended the skiing day a bit early, and ended up at the Aerie restaurant for dinner.



We all left early Thursday morning, after some of us had a quick bite to eat in our rooms. Phil and Steve flew back to Omaha; Ben and Dale drove back, while Mark drove back to Colorado Springs. We had good weather on the way back, and all of us made it back home in one piece. This was the first time in many years that most of us had been to Snowbird and Alta.

Overall, the trip had 25 members, five from Omaha Ski Club and the other 20 from nine other CMSC clubs. It was a great trip!
