# Kitzbühel 2018

Three Omaha Ski Club members, Ben, Maggie and Mark, participated in this season's Chicago Metropolitan Ski Council (CMSC) Europe ski trip to Kitzbühel, Austria, from Friday, January 26<sup>th</sup> to Saturday, February 3<sup>rd</sup>. Kitzbühel is in northwestern Austria near the German border (red marking on map at right). It's composed of several interconnected ski areas. We spent six days skiing, on January 28<sup>th</sup> through February 2<sup>nd</sup>; the 26<sup>th</sup>, 27<sup>th</sup> and 3<sup>rd</sup> were travel days. CMSC is a group of over 70 ski clubs; 97 of their members, including the three Omaha Ski Club skiers, were on the trip. The group stayed in the large and pleasant Maria Theresia hotel.



Getting to Kitzbühel was time-consuming. Ben and Maggie began the process with a one-hour flight on United from Omaha to Chicago's O'Hare airport; Mark drove from Colorado Springs to Denver and then had a 2-hour United flight to Chicago. Once at O'Hare, we picked up our luggage, did a bag drag from the United to the Delta terminal where we met the rest of the CMSC skiers, then checked in again at Delta. We then got on a 2-hour flight from Chicago to Atlanta which was followed by a 9-hour flight to Munich and then a 3-hour bus ride to Kitzbühel. Along the way, we shifted time zones; Austria is 7

hours ahead of Omaha and 8 hours ahead of Colorado. We arrived early enough in the afternoon to take a quick walk around the surrounding town, find the Hahnenkamm gondola and then return to eat dinner at the hotel. Our rooms had some interesting closets and ceiling decorations.



We skied six days at several of the Kitzbühel ski areas in a wide variety of weather and snow conditions. As on past CMSC Europe trips, we spent some of the time skiing with a group of experienced people who were primarily advanced skiers and had been to the area before.

We began our first skiing day, Sunday the 28<sup>th</sup>, with variably cloudy and mild conditions. Mark started skiing right away; Ben and Maggie had to visit a local ski shop first to resolve some binding problems and rent some skis. Once on the slopes, the snow conditions turned out to be quite good – the area had received lots of new snow in the previous several weeks. That night, and every following night, we had dinner at the hotel – it was included in the price of the trip. Breakfast at the hotel was also included.

Monday the 29<sup>th</sup> was a perfectly clear bluebird day. All three of us took advantage of the great conditions to have a good time skiing many parts of the area. We also stopped by some of the on-mountain facilities.



The following day, Tuesday the 30<sup>th</sup>, we had cloudy weather and flat light, which made skiing a little more challenging. We were still able to enjoy the scenery and restaurants on the mountain.



Wednesday, the 31<sup>st</sup> was another bluebird day. We spent a fair amount of time near the Kirchberg base.



On Thursday, the 1<sup>st</sup>, the weather started out mostly cloudy and changed to heavy snow and fog. The low visibility was challenging. We made the best of the conditions and stayed near the Kitzbühel gondola once the weather got bad.



Our last skiing day was Friday, the 2<sup>nd</sup>. This started out cloudy, foggy and snowy but conditions improved by the end of the day. We stuck to the main runs near the Kitzbühel gondola for most of the morning and went a little further away when the visibility improved in the afternoon. It was nice to ski on the several inches of fresh snow that fell Thursday night. Ben and Maggie took a nice walking tour of the town of Kitzbühel on Friday evening.



We left Kitzbühel early Saturday morning on the 3<sup>rd</sup>, had a 2-hour bus ride to Munich followed by a 10-hour flight on Delta back to Atlanta. Ben and Maggie then took a Delta flight back to Omaha, and Mark took a Delta flight back to Denver and drove back to Colorado Springs – we all took a while to get back. Everyone made it home fine. An excellent trip!

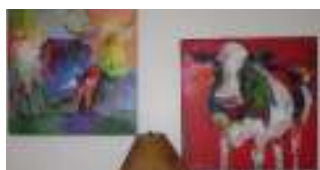
# CMSC Steamboat Trip

After the races, we had a picnic at the Bashor Picnic area at the bottom of the race course. This year, it was warm and the food didn't freeze before we got it to our mouth. We skied the rest of the day. During the afternoon, we stopped at Four Points for a short break and to take photos. We were getting our



skis on and noticed Joe's ski going down a black bump run without Joe. There Joe was, standing with one ski on and the other one down the hill. Phil went to get it. It had made its way down the mountain about 4-500 yards before stopping. Fortunately, it didn't hit anyone and finally stuck in the snow. The brake had frozen. The ski was reunited with Joe and we

went to ski. It will be a good story for many years. That evening, we enjoyed the hot tub and another freshly baked apple pie with ice cream.



Tuesday 2/27, Felix wasn't feeling too well and took the day off. The seven of us skied together. Maggie was in the lead most of the time. When we got to Four Points, we wanted to take Joe down the path his ski had gone, but they had groomed the run. Maggie suggested the run next to it, which was Nelson's Run. It was a lovely mogul run...very large moguls with occasional rocks. We all enjoyed that long, black run. We finished the day with après ski at Bear River.

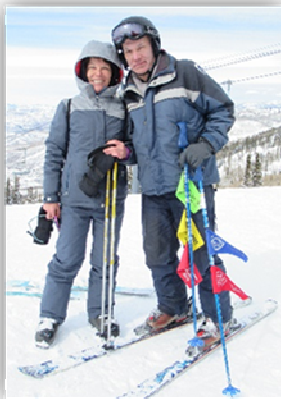
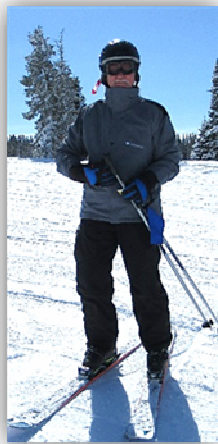
