Trips 2018-2019

I am excited to begin a new season! Everything gets so busy as fall approaches. All the details for the trips need to be finalized, spreadsheets prepared, trips flyers formatted, dates finalized and information placed in the newsletter, website and on our Meet-Up site. This summer has flown by and there are reports of snow out west. I have heard several forecasts for this season, some say we will get higher than average snow, while others say below average. Only Mother Nature knows. I hope that it is a deep powder year!

We have some great trips again this season! We have planned most of our trips around the IKON pass. First, we visit Copper Mountain with the Cornhusker Ski Club. This trip has been a good start to the season as we get in shape, check our gear and make sure all the warm weather clothing still fits. This trip will kick off our season.

Next, we will bring in the new year at Powderhorn (at least we will try again this year). We stay at the Grand Vista Hotel in Grand Junction CO. It is a half hour, very scenic drive to the resort. Grand Junction is the nearest "big" town by Powderhorn. We can find somewhere to bring in the new year close to the hotel.

At the end of January, we will spend a week at Steamboat Springs with the Flatlands Ski Association. This is always a fun trip. The skiing is usually great and we get to spend time with old friends. The Welcome Party and banquet, as well as a picnic, are included with this trip. We will be staying at the Timber Run condos this year with three outdoor hot tubs and a pool. It is easy to get from the condos to the mountain or to town with the dedicated shuttles. We need to drop some rooms soon. If you have not signed up yet, get your trip application turned in soon or you may not get a spot!

In February, we drive out to Winter Park for 3-4 days of skiing. In February, usually the snow is great and the entire area is covered. We will be staying at the Best Western Alpenglo Lodge in the town of Winter Park, close to shops, restaurants and the bus stop. It is possible to take the train into Frasier, leave your luggage at the hotel and go ski. This trip includes four nights lodging and a welcome party.

March brings us Spring. Hopefully, the snow will still be in winter mode as we fly to Salt Lake City for a week of skiing. We will be staying at the Crystal Inn Hotel & Suites Midvalley in Murray UT, 20 minutes from the slopes. We will ski at least one day at each of the resorts of Brighton, Solitude, Alta and Snowmass. Twenty spots are available. I am depending on you to sell these spots! Bring your friends and let's go ski!

At the end of the season, I travel to the Mountain Travel Symposium. This is where I meet with vendors and tour operators to plan next year's trips. I cover the cost of this trip since it gives me good contact information for planning as well as meeting people from other clubs for possibly teaming up on trips. Since we have a relatively small member base, I try to find places and groups to pair up with to keep the costs down. The bigger the group, the better the price. Let's try to grow our club's membership! Let's start this year!

OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$28.00 charge on any returned check.

TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7). Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7).
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

CANCELLATIONS AND REFUNDS

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.
- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 7)above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
