# Steamboat CO Trip January 20-27, 2019



Eight members of the Omaha Ski Club (Teri Hammon, Phil Bintz, Steve Grunberg, Kim Lee, Kim Copenhaver, Richard Wilson, Dave Burden and Joe Reitman) traveled to Steamboat for the early trip and some great powder! We arrived on Sunday, rested and enjoyed a balloon glow at the base. I had never seen the balloons being inflated. They were very pretty and very large when you were standing next to them. I even got to hang on to one of them. I was glad it anchored to something that weighed more than I did. We stayed at the Timber Run Condos. These were three bedrooms plus loft or two-bedroom condos. The complex had three large outdoor hot tubs and a pool. The shuttle took us to the base area daily and was on-call if we needed to go elsewhere.

Monday, we enjoyed skiing around the area, getting familiar with the runs and lifts. It was cloudy and cool. The sun came out in the afternoon for a few runs. The snow was in good condition, except for the bumps on Middle Rib. We watched some of the Cowboy Downhill in the afternoon. Wednesday was another cold, overcast day with snow showers. We had fun skiing together. We made it into the Shadows and Closets. The snow was fresh and untracked in places. These were the best runs all day! By evening, the other 17 members of the Omaha Ski Club had arrived (Dave Griffith, Vance Peterson, Ben & Hillary Stickler, Andy Rabick, Brian & Cindy Moore, Pat Connelly, Jamie & Simon Lewis, Len Szmurlo, Dan & Janice Hitzfelder, Gail Shears, Joe Fassel, Dan Kautzman and El Siebert). Teri and Phil had FSA meetings and later handed out the welcome packets, activity tickets and lift tickets. It was good to see past members David Griffith and Dan Kautzman. Dan traveled the farthest from Florida. We had several members of the Summit County Branch of the Omaha Ski Club (Jamie & Simon, Len, Danny & Janice and Joe and Gail). Welcome to all of our new members!

Thursday, several of us skied together. There had been several inches of fresh snow overnight and with the low light conditions, it made for a challenging day on some of the runs. On the last run, Vogue, Kim Lee fell and twisted her knee and was unable to ski the remainder of the trip. We met at the little red schoolhouse for the Snowshoe races. It was a quick race since we only had one team. Our team, Phil Bintz, Jamie Lewis, Hillary Stickler and Joe Reitman, gave it a good effort and ran the course without falling. It was fun to watch even though we didn't come in first or second or third. The Welcome Party that evening, was held in the Champagne Powder Room at the top of the gondola. Billy Kidd spoke to the group, raffle tickets were sold for prizes (\$200 cash, a pair of skis, and two \$150 gift certificates to Christy Sports), and we had potatoes and chili. After dinner, there was music and dancing.



Friday we were up early, ready to race! First to race were the 50+ men's group. With hugs for good luck, everyone got down the course without too much trouble. The race for the young men went well too. Next, the women raced. It took a bit longer since they only had one course set up. Overall, 18 of the 25 Omaha Ski Club members participated in the races. Richard Wilson from St Louis, who had joined Omaha for the race, placed first in his age bracket, Phil Bintz placed third in his age bracket, Teri Hammon and Hillary Stickler placed first in their age brackets. Overall, Omaha placed 5<sup>th</sup> of 9 clubs. Several members received NASTAR medals for their best times on the race course. These included Bronze medals to Hillary Stickler, Jamie Lewis, Dave Griffith, Joe Fassel, Vance Peterson, Simon Lewis; Silver medals to Phil Bintz in both the Open and the Challenge Race; and Gold medals to Teri Hammon and Richard Wilson.



Saturday, I spent the morning in the emergency room with severe pain from an abscessed tooth. I am told the skiing was good, the picnic was great and the race director's race was fun. I was able to attend the Awards Banquet that evening at the Steamboat Grand Ballroom. It was a nice evening and the food was very good. **OMAHA SKI CLUB TRIP POLICIES**

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$28.00 charge on any returned check.

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.
- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 7)above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

**TRIP SIGN-UP, DEPOSITS AND PAYMENTS**

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7). Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7).
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

**BUS TRIPS**

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
