Taos Feb 18-23. Ernie Blake started Taos Ski Valley in 1955. I have been to Taos twice. Once, they closed the mountain just as I was getting on the lift due to too much snow! I hope they have a good snow year and I will be able to ski the entire mountain. We will be staying in the town of Taos so we can explore this unique little town.

I have skied Copper Mountain many times. We will team up with the Cornhusker Ski Club and enjoy this great area. The whole mountain should be open to explore. If you would like a tour of the mountain, we have friends that are mountain hosts that would love to show you around.

If you haven't had enough skiing, join us at Big Ski March 10-15. The resort was founded by Chet Huntley, a co-anchor at NBC news and a Montana native. Big Sky opened in 1973. Moonlight Basin is a fun part of the mountain and was added in 2013. In 2018, Doppelmayr put in America's first highspeed 8-pack lift. This is a great place to ski.

# Trips 2019-2020

Summer is winding down and fall is almost here. I am not rushing things, but ski season is almost here! I have been busy finishing the final touches on all of the trips for the coming season. I am happy to announce the line-up of trips for the season!

We begin the season with a drive out trip to **Snowmass** along with the Cornhusker Ski Club. We will stay at the Tamarack Condos with their fantastic hot tubs. It is a close walk or shuttle to the snow and will give us a chance to find our gear and make sure our legs are in shape. We will stay four nights, but will have a chance to ski for 5 days if the snow is good.

Next, we will go to **Winter Park** after the New Year. We will stay at the Best Western Alpenglo Lodge in downtown Winter Park. This will give us another chance to get our legs in shape for FSA. Note to self...Don't overdo it in the trees and bumps!

The FSA trip takes us to **Steamboat** again this year for some great skiing, racing, parties, old friends and free beer (thanks to our sponsor Boulevard Beer). We will stay in Eagle Ridge townhomes with short shuttle rides to the mountain. This trip has an option of either four- or seven-night stay. There will be a Welcome Party and an Awards Banquet. In addition, we will have après ski deals and mildly competitive races. Also, sign up to be on the snowshoe team. Everyone is welcome.

Following the FSA trip, we travel to **Taos NM** for five nights of lodging in the Taos Valley Lodge in the downtown area. The free shuttle will take us to and from the mountain and we will have breakfast daily. I am hoping for another year of heavy snow in this area.

Next, we hit the slopes at **Copper Mountain**. It will be fun to have the whole mountain open, unlike the early season trips. We will stay at one of the Silver level condos and will also be with the Cornhusker Ski Club.

Finally, we go to **Big Sky MT** for five days of skiing. We are staying at Buck's T4 Lodge with free shuttle to the mountain. The Lodge is hotel style with free breakfasts daily.

We felt it necessary to announce the trips early since many of you have to request vacation early. The full trip flyers will be posted on the website at [www.omahaskiclub.org](http://www.omahaskiclub.org) under trip information. The spots are limited, so sign up early. You can send your trip application and deposit to the PO Box anytime after this announcement. I would encourage you to come to the sign-up party to enjoy the company, talk about the trips and find out who else is going with you. Bring your friends. You never know who may want to join you!



I am also excited to hear the news that Arapahoe Basin announced it was going to join the IKON PASS! One more place we can go. Do you have your IKON PASS yet? It is going to be a great season. I hope you will join us for a trip or two!

**OMAHA SKI CLUB TRIP POLICIES**

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$28.00 charge on any returned check.

**TRIP SIGN-UP, DEPOSITS AND PAYMENTS**

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7). Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7).
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

**CANCELLATIONS AND REFUNDS**

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.
- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 7)above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

**BUS TRIPS**

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption.
