Big Sky Montana

March 10-16, 2020


Six members of the Omaha Ski Club traveled to Big Sky, a trip of about seventeen driving hours. We arrived on Tuesday and checked into Buck's T4 Lodge. The lodging was wonderful. We had large rooms, comfy beds and a large breakfast buffet daily. There were two large outdoor hot tubs and a commons area in the lodge. There was also a bar and restaurant on the premises. We



made reservations for dinner on Sunday.

That evening, we enjoyed the hot tubs and went to Riverhouse Grill for dinner. They had great fried chicken and BBQ. It was a local's place with good food and cheap drinks.

In the morning, we drove to the ski area. It was cloudy and the snow was good. They had several inches of new snow the previous day. The sun broke through in the afternoon and we were able to get some great shots of Lone Peak. We skied all day and only covered about a third of the mountain. It had been several years since I had been here, and it was new to a couple of the members. The new lift, The Ram Charger, had heated seats, carried eight passengers and had a bubble to protect you from the elements. Once the bar was down, it locked and automatically released at the top. Next season, they will replace the Swift Current Lift. We finished the day with a ride in a cart, pulled by a truck, to the parking lot. After returning to the lodge, we relaxed in the hot tub and then we were off to the Welcome Party at the Lone Peak Brewery. They had great food. We had the bison steak rice bowls and jambalaya.



Thursday, we had sunny skies and mild temperatures. There was a little fresh snow overnight. Jamie and I toured the Big Sky side of the mountain with a Mountain Host. We learned that the runs Pomp and Lizette were named after

Sacajawea's children. There are also geothermal areas on the mountain. Mr. K's run is named in honor of Everett Kircher, the founder of Boyne USA. Lone Peak is part of the Madison Mountain Range. We enjoyed learning about the mountain and exploring different runs. We had to try the trees of Lizette and the moguls in the Ambush Glades. We finished the day in the glades and returned to relax in the hot



tub. Later that evening, we found a little place called Milkie's Pizza and Pub for dinner. It was a "hole in the wall" local's bar with burgers, pizza, calzones and some interesting people.





Friday, it was partly cloudy and chilly. There were more people than during the week. We explored the runs on Moonlight Basin and stopped at the yurt at Madison base area for lunch. It was a great day to ski. The views are fantastic from the top of the mountain. We finished the day and relaxed in the hot tub, visiting with a family from Wisconsin. We discovered that Vail Resorts and Alterra Resorts were closing for a week due to the Coronavirus (Covid-19). Nothing about Big Sky...yet. We liked the rice bowls so much, we returned to the Lone Peak Brewery for the Salmon rice bowls.



Saturday, we checked the website and the mountain was still open. Let's go ski! We were blessed to see a herd of Elk crossing the road in front of us. Beautiful creatures. It was cloudy, cold and snowing. We enjoyed the snow, the trees and all the vertical we were tracking! That evening, we returned to the Riverhouse for dinner.



Sunday, we got the bad news. Big Sky was closing today. With all the other resorts closed, this was probably our last day for the season. A sad day indeed. It could have been worse! We had snow, fresh powder and in the afternoon, the sun came out! We had fun on this last day. We were tired at the end of the day. Took Ambush Glades for the last run and took time to thank God for this beautiful day with



great friends! We went back to the lodge, relaxed in the hot tub and went to get ready for dinner only to find out that the restaurant had closed. We decided to try Ousel & Spur Pizza Co. They had wonderful beet salad and pizza.



Monday, we loaded the car and went to grab breakfast. It was "grab and go" only, no buffet. As we traveled back to Nebraska, we were unsure of what was going to happen due to the Coronavirus (Covid-19). The horror stories were coming from China and Italy. Many groups had overseas trips cancelled. The schools, retail stores, businesses, restaurants, and bars were closing. People were told to maintain social distancing, six feet apart, and to stay home.
