

TRIPS NEWS AND SIGN-UP INFORMATION

Once again, fall is here and we are getting ready for the ski season. Personally, I cannot wait! Let it snow! This has been a year of challenges and changes and a new vocabulary of terms to go with the pandemic. I am being optimistic, but until there is a vaccine, I don't see anything getting better soon. We will still have masks, social distancing, hand washing, and crowds will be limited.

This theme will carry over into the winter and the ski season. Resorts are limiting the number of visitors, there will be no walk-up, over the counter sales of lift tickets. You will need to buy tickets in advance if you do not have a season pass or IKON/EPIC Pass. Most places are giving priority to season pass holders and groups that are scheduled. This would include both of our trips to Telluride and Mammoth.

What to Expect: We plan to go to Mammoth with the CMSC group February 27-March 6, 2021. These are some of the regulations that they will have in place to deal with Covid-19 (taken from their website https://mammothmountain.com/covid):

What can I expect while riding chairlifts, gondolas, and shuttles?

Masks are required while inside any of our facilities and while waiting in line for, and while riding shuttles, lifts, and gondolas. Guests will not be required to load chairlifts or gondolas to full capacity, and can opt to ride only with people within their party. Additionally, lift mazes will be altered to facilitate increased distancing.

Will on-mountain capacity be limited?

Daily skier visits will be carefully managed and daily lift ticket sales will be regulated to help mitigate crowding and provide the best opportunities for social distancing.

Will face masks be required?

Face masks are required indoors, in lift lines, lodges, restaurants, shuttles, gondola cabins, and outdoors when social distancing of six feet is not possible.

Will shuttle busses operate?

Shuttles will operate at a reduced capacity following state and local guidelines. Currently busses are operating at 50% capacity.

Will guests be allowed in lodges that do not have lift tickets or passes? Access to lodges and indoor facilities will be prioritized for pass and ticket holders.

Bill Monahan 1934 – 2020

It is with regret that the Omaha Ski Club announces the recent death of longtime member Bill Monahan. Here is his full obituary.



William L. "Bill" Monahan

March 25, 1934 – September 19, 2020

Bill was preceded in death by his parents, William T. Monahan and Emma K. "Bobbi" (Schluntz) Monahan and sister Ellen E. Butler. He is survived by sister, Katie Karrer (Lee); brother, James H. Monahan; several nieces, great nieces, nephews, great nephews and by his dear friend, Kathleen Moran.

Bill grew up in the Cathedral Parish and graduated from Omaha Creighton Prep. After serving in the U.S. Marine Corps, Bill graduated from Creighton University and Creighton Law School in 1962. He was a member of the Nebraska State and Omaha Bar Associations. He practiced law in Omaha for more than 50



years beginning with the Legal Aid Society and Nebraska Department of Social Services. In later years he was in private practice with his brother, Jim and niece, Maureen K. Monahan. He also served as vice-president of Parking Management & Consultants, a family owned business operating parking lots and garages in downtown Omaha.

Bill served as a board member of Greater Omaha Community Action, GOCA and a member of several Omaha services organizations, the Ancient Order of Hibernians and Knights of Columbus. He was a Boy Scout leader and active member of St. Margaret Mary parish.

Bill spent much of his time at his cabin at Thomas Lakes along the Platte River. He loved canoeing, boating, and sailing. He canoed on the Platte and Niobrara Rivers in Nebraska and made several canoeing trips to the Boundary Waters, to Canada and beyond. Bill skied in Colorado in the winter and sailed his sunfish and catamaran in the summer. He will be greatly missed by his family and friends.

OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$28.00 charge on any returned check.

TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7). Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7).
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

CANCELLATIONS AND REFUNDS

- 7) Unless otherwise listed in individual trip information. cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.
- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption.
