2021 Trips Update August

I hope everyone is having a great summer. It's hot and humid this month and doesn't that make you wish it was December already. I sure look forward to the cold and snow and SKIING!!!

It was a slow year last year with only one trip. I was thankful that we had that. The pandemic is waxing and waning over the past year and now, ramping up again with this Delta variant. Hopefully, all of our members have had a chance to get their vaccinations.

We are not planning a trip sign-up party this year. The trips have been posted. Now that we are meeting in person again, I am available for questions and do carry membership applications, trip applications and Covid waivers with me at the events, all you need is your checkbook. These are available on the website at omahaskiclub.com. Remember, Membership fees increase after September 30th.

Speaking of trips, we will start the season with a trip to **Summit County December 8-12, 2021**. We are staying in Dillon at the Best Western. Here we can travel to several resorts, depending on which pass you have. There is the Summit Stage stop near the hotel which takes you to Frisco transfer station. From there you can travel to Copper, Keystone, Breckenridge and Arapahoe Basin. We have left the choice up to you, depending on which pass you hold, IKON or EPIC. It will be a nice time to get out and test your gear. We have only 10 spots for this trip and 5 of them are filled. I will keep this trip open until the first part of December, but try not to delay in signing up, you may not get a space!

Next, we will go to **Telluride with the Flatland Ski Association (FSA) January 22-27, 2022**. We are staying at the Mountain Lodge, 2 bedrooms, 2 bath condos. We stayed here last year. It is a short walk to the slope, almost ski in, ski out. I have 28 spots available until OCTOBER 1st. We have 15 signed up so far. I will drop rooms on October 1st. I can't stress this enough, sign up NOW if you plan to go. Once the rooms are gone, the sign ups will close. We have to do this to decrease our financial liability as Telluride has a strict payment schedule. If you want to go on this trip, do not delay signing up early!

At the end of February, we will venture out to **Ski Utah, February 20-27, 2022**. We will stay at Crystal Inn and take the shuttle to Snowbird, Alta, Solitude or Brighton. We may take a day and ski Deer Valley or Park City as these are only 34 miles from where we are staying. We have 12 spots available and 8 sign-ups so far. Again, don't delay if you plan to go with us. There is a hotel shuttle available to and from the airport, if you wish to book your own flight for this trip. Notify the trip leader if this is what you plan to do.



Depending on the participation in the three trips and the snowfall this season, we hope to have a fourth trip sometime in March. This will be announced in the future.

I am excited for the upcoming season and hope you are too! Now is the time to sign-up for a trip or two. I hope to see you at our next gathering.

OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$28.00 charge on any returned check.

TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7). Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7).
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

CANCELLATIONS AND REFUNDS

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.
- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 7) above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption.



**WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19
June 2021 – May 2022**

The novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.
