**WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19
June 2020 – May 2021**

The novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. Releasor on behalf of him/herself and on behalf of Releasor’s heirs, assigns, personal representatives and next of kin, **HEREBY RELEASES AND HOLDS HARMLESS** the Omaha Ski Club its officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, volunteers and if applicable, owners and lessors of premises used to conduct the event, (“Releasees”) **WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH**, or loss or damage to person or property, **WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.
